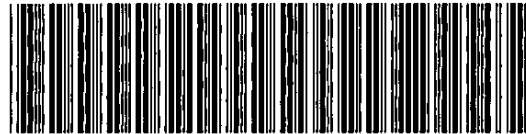




Article VIII - Member's Right to Continue Business
