

# ARTICLES OF ORGANIZATION OF EMERALD CATERERS SOUTH, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited FLORIDA Liability Company Act, pursuant to Chapter 608 of the Florida Statutes, hereby makes, acknowledges and files FLORIDA the following Articles of Organization (the "Articles").
