

The Articles of Organization for Client First LLC were filed on June 14, 2006 and assigned document number L06000061503.


SECOND

James Denney pursuant to an agreement with Managing Member and Registered Agent Trecia Denney, and Managing Member Darren Denney reduces his interest in Clients First LLC, a Limited Liability Company organized under the laws of the State of Florida, from 25% to 15%. In consideration thereof James Denney received payment of \$100.00 from Trecia Denney.

Darren Denney, pursuant to an agreement with Managing Member and Registered Agent, Trecia Denney, and Managing Member James Denney reduces his interest in Clients First LLC, a Limited Liability Company, organized under the laws of the State of Florida, from 50% to 10%. In consideration thereof Darren Denney received payment of \$400.00 from Trecia Denney.

Trecia Denney upon payment as set forth above shall have 75% ownership in Clients First LLC. James Denney shall have 15% ownership in Clients First LLC, and Darren Denney shall have 10% ownership in Clients first LLC.
