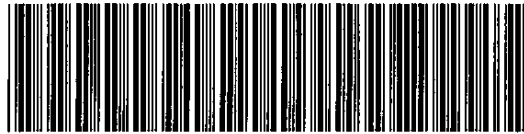

ARTICLES OF ORGANIZATION

FOR

AR ST. ALBANS, LLC

The undersigned, as authorized agent of a Limited Liability Company to be formed under the Florida Limited Liability Company Act, as Amended (the "Act"), hereby forms a Florida Limited Liability Company (the "Company") pursuant to the Act, and hereby sets forth the following Articles of Organization (the "Articles"):

ARTICLE I

Name

Principal Office


The street address of the principal office of the Company shall be 7318 Westminster Court, University Park, FL 34201-2342.
