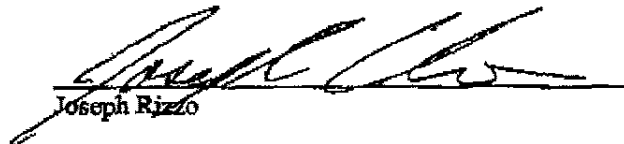
ARTICLE VI:
