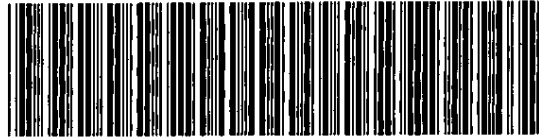



Principal Office




