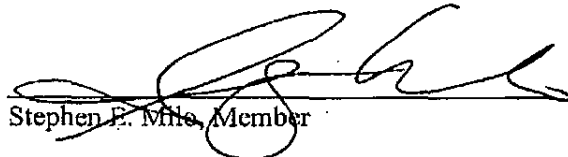
Article VIII

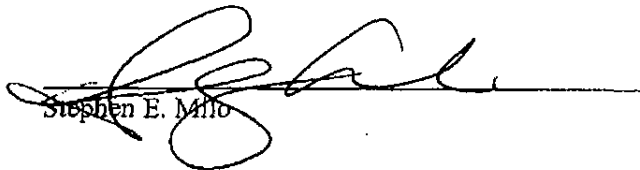
