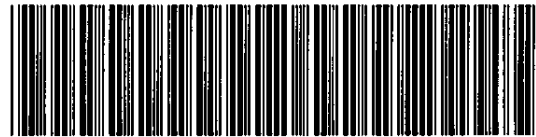


ARTICLE VII
