# ARTICLES OF ORGANIZATION 20 A 11: 02 for AJJ HOLDINGS, LLC TALLAHASSEE, FLORIDA

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges, and files the following Articles of Organization.

#### ARTICLE I - NAME

The name of the limited liability company shall be AJI Holdings, LLC ("Company").

## ARTICLE II - ADDRESS

The mailing address and street address of the principal office of the Company shall be 1282 LaQuinta Drive, Suite 8, Orlando, Florida 32809.

#### ARTICLE III - DURATION

The Company is to exist perpetually.

#### ARTICLE IV - PURPOSES AND POWERS

The general purpose for which the Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida and as authorized by the Operating Agreement of the Company.
