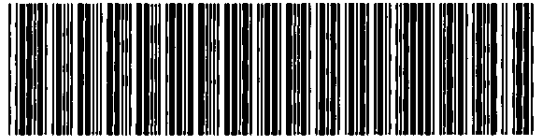

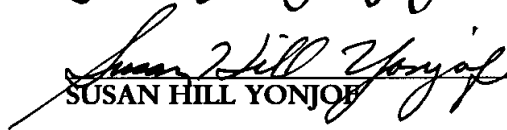
DURATION

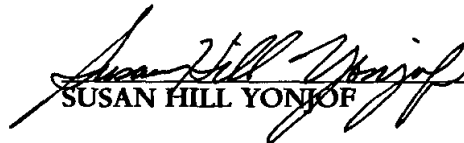
