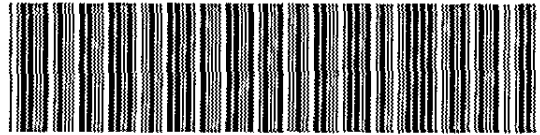

ARTICLE I - NAME

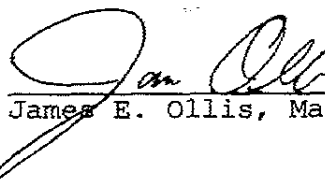
The name of the limited liability company (the "Company") shall be Sunny Property Development, LLC.
