## ARTICLES OF ORGANIZATION

OF

#### Thunder Bikes, LLC

The undersigned, under the provisions of Chapter 608 of the Florida Statutes (the "Act"), for the purpose of forming a limited liability company under the laws of the State of Florida do set forth the following:

#### 1. Name.

Any and all action by the Company shall require the vote of members holding a majority interest in the Company.

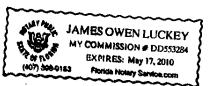
