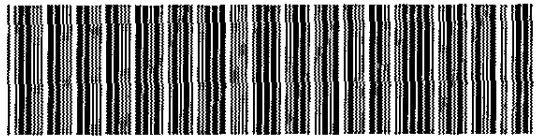

**AMENDED AND RESTATED
ARTICLES OF ORGANIZATION OF
FLORIDA'S TITLE AGENCY, LLC**

NAME
