ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Fla. Stat. ch. §§ 608.401 et seq., as amended from time to time (or any corresponding provisions of succeeding law) (the "Act"), hereby make, acknowledge, and file the following Articles of Organization. ARTICLE I - NAME

ARTICLE VI - ADMISSION OF NEW MEMBERS

In the absence of any additional Members, the Company may function and operate without any Operating Agreement. Once there is more than one Member, the Company will be governed by a written Operating Agreement. A Majority in Interest of the Members shall have the right to admit additional Members upon such terms and conditions as are provided in the Operating Agreement governing the Company. Transfers of a Member's interest in the Company may be made only upon compliance with the terms and conditions set forth in the Operating Agreement governing the Company.

ARTICLE VII - MANAGEMENT

So long as there is only one Member of the Company, the Company shall be Member-managed by such sole Member. 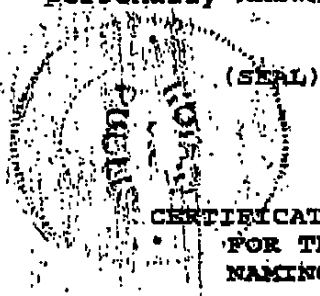
