ARTICLES OF ORGANIZATION OF CAE, PLLC

The undersigned, for the purpose of forming a professional limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 621, hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I

Name and Purpose. The name of the professional limited liability company shall be CAE, PLLC ("Company") and the purpose of the Company is to provide specialized medical services.
