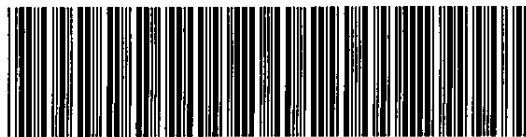

# ARTICLES OF ORGANIZATION OF CESNAC PUMP COMPANY, LLC

## Article I

The name of the limited liability company ("Company") is CESNAC PUMP COMPANY, LLC.
