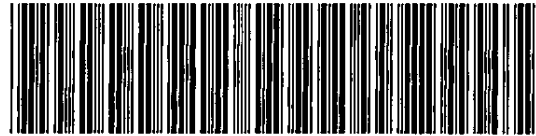

**ARTICLES OF ORGANIZATION OF
D&M PROPERTIES, LLC**

(Pursuant to Section 608.407, Florida Statutes)

ARTICLE I - NAME

The name of the limited liability company is D&M PROPERTIES, LLC.

ARTICLE II - ADDRESS

The mailing and street address of the company is 6650 Elva Street, Milton, Florida 32570.

ARTICLE III - INITIAL MEMBERS

The company is not a manager-managed company. An operating agreement approved first by all initial members, subject to amendment by a majority thereafter, shall control the day-to-day operations of the company.




