The mailing address and street address of the principal office of the Limited Liability Company is **2502 Sand Mine Road, Davenport, FL 33897.**

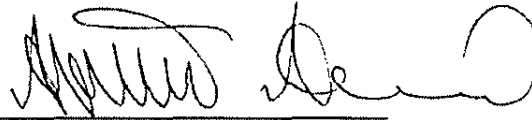
Article III

The name of the Registered Agent is **Aftab A. Khan** and whose Florida street address is **9003 Kilgore Road, Orlando, FL 32836.**

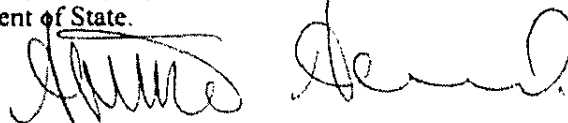
