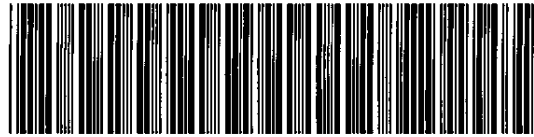

The undersigned hereby executes and acknowledges these Articles of Organization are for the purpose of becoming a limited liability company under the laws of the State of Florida, providing for the formation, rights, privileges and immunities of limited liability companies for profit and hereby adopt the following Articles for such limited liability company:

ARTICLE I
Name and Principal Office

The name of this limited liability company is ISLANDS OF BEAUTY LLC. Its principal office is located at 323 W. Lady Lake Boulevard, Lady Lake, Florida 32159 and its mailing address is 323 W. Lady Lake Boulevard, Lady Lake, Florida 32159.

ARTICLE II
Duration

The duration of this limited liability company shall commence on the date of filing of the Articles Of Organization by the Florida Department of State until a written declaration by the manager that the limited liability company is dissolved.

ARTICLE III
Purpose

This organization is to be managed by a manager who is the sole member of the limited liability company. The manager, who shall serve until her death, resignation, replacement or dissolution of the limited liability company, shall be RUTH M. McKINNEY.


ARTICLE VII Amendment of Articles Of Organization


ACCEPTANCE OF APPOINTMENT OF REGISTERED AGENT
