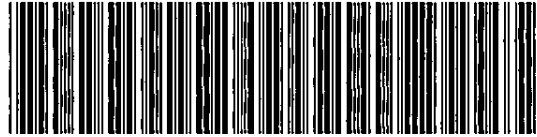

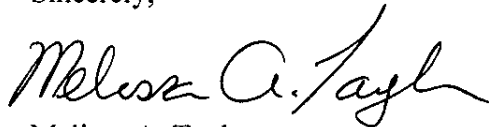

1. The name of the company prior to this Amendment is: **AT YOUR REQUEST LLC.**
2. The original Articles of Organization were filed with the Department of State on June 22, 2006; which Articles were amended by Amendment dated April 2, 2007; further amended by Amendment dated July 16, 2007; and further amended by Amendment dated October 16, 2008.
3. This Amendment changes the name of this company to **RESULTS GROUP, LLC**, and, therefore, old Article I of the company's Articles of Organization is hereby deleted and new Article I is added and shall read as follows:

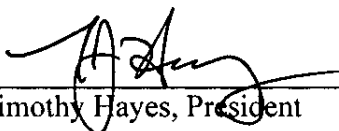
**“ARTICLE I - NAME**
