Article I. Name: The name of the Limited Liability Company is **LAKE GRIFFIN HOLDINGS, LLC**.



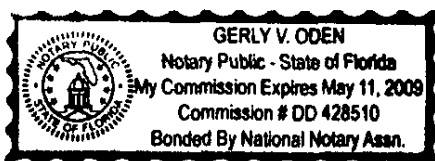


