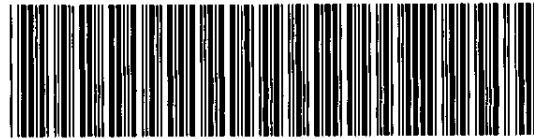

3G, LLC**


