**SECOND ARTICLES OF AMENDMENT TO  
ARTICLES OF ORGANIZATION  
Digital Café Tour, LLC  
(A Florida Limited Liability Company)**

**FIRST:** The date of filing of the articles of organization was July 26, 2006, and assigned document number L06000064076.

**SECOND:** The following second amendment to the articles of organization was adopted by the limited liability company on March 16, 2007 by the unanimous vote of the members and managers:

**Article III**

The purpose for which the Company is organized is any lawful business purpose and as stated in the operating regulations of the Company.

**Article VI**

The Company shall be managed by one or managers unless otherwise stated in its operating regulations.

**Article VII**

The managers, officers, members, and financial interest holders shall not be personally liable for the debts, obligations, or liabilities of the Company.

**Article VIII**

The power to amend, alter, or repeal these Articles of Organization shall be vested in the members by a vote of two-thirds of the membership interests allocated to the members.

**Article IX**

The Company shall consist of voting and non-voting ownership interests which shall share equally in the profits and losses of the Company pursuant to the operating regulations of the Company.


**Article X**

The operating regulations of the Company shall reflect restrictions on the transfer, pledge, or encumbrance of any ownership interests in the Company.

**Article XI**

The Company's existence shall be perpetual.
