## ARTICLE VII


Operating Agreement



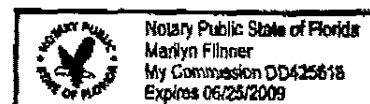


