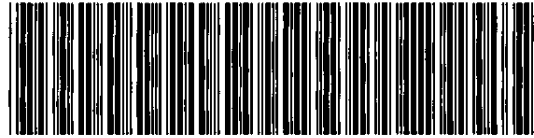

ARTICLES OF ORGANIZATION
OF
CSA PEDIATRICS, P.L.

The undersigned hereby certifies that he is the Authorized Representative of a Member who is forming a Professional Limited Liability Company under Chapter 621, Florida Statutes. The following Articles of Organization are hereby adopted:

ARTICLE I.
NAME

The name of the Professional Limited Liability Company shall be CSA Pediatrics, P.L.

ARTICLE II.
DURATION; EFFECTIVE DATE

This Professional Limited Liability Company shall exist perpetually, commencing as of July 1, 2006.

ARTICLE III.
ADDRESS; PRINCIPAL OFFICE

The mailing address of the Professional Limited Liability Company and the street address of the principal office of the Limited Liability Company is 6006 49th Street North, Suite 310, St. Petersburg, Florida 33709.

ARTICLE IV.
INITIAL REGISTERED OFFICE AND REGISTERED AGENT

ARTICLE V.
PURPOSE

This Professional Limited Liability Company is organized for the purpose of owning a partnership interest in Cardiac Surgical Associates, LLP, a Florida limited liability partnership and to operate a group medical practice through Cardiac Surgical Associates, LLP. This Professional Limited Liability Company shall engage in no other business.
