These Articles of Organization are made for the purpose of organizing a Florida Limited Liability Company under the Florida Limited Liability Company Act (Florida Statutes Chapter 608).

**ARTICLE I - NAME**

The name of this Limited Liability Company is R & J RESTORATION, LLC.

**ARTICLE II - MAILING ADDRESS**

The mailing address and street address of the principal office of R & J RESTORATION, LLC, 1079 Dees Drive, Oviedo, FL 32765.

**ARTICLE III - DURATION**

The period of duration for R & J RESTORATION, LLC shall be perpetual from the date of filing these Articles with the Department of the State, except for the limitations set out in Florida Statutes Section 608.441.

**ARTICLE IV - REGISTERED AGENT & OFFICE**

**ARTICLE V - ADDITIONAL MEMBERS**

Additional members to the Company may be admitted, but only if all the current members agree to the admission of the additional members and to the terms of admission.

**ARTICLE VI - TERMINATION OF MEMBERSHIP**

If a member of the Company dies, retires, resigns, is expelled, is dissolved, experiences bankruptcy, or upon the occurrence of any other event which terminates the continued membership of a member in R & J RESTORATION, LLC, the remaining members may, by unanimous agreement, continue the business of R & J RESTORATION, LLC.

## ARTICLE VII - MANAGEMENT


