**AMENDED AND RESTATED ARTICLES OF ORGANIZATION
OF
PEARL CHU KWONG M.D., PLLC**

Pursuant to the Florida Revised Limited Liability Company Act, Chapter 605, Florida Statutes, the undersigned manager and authorized representative of the members, hereby adopts the following amended and restated articles of organization (these "*Amended and Restated Articles of Organization*") of **PEARL CHU KWONG M.D., PLLC**, a limited liability company duly organized and existing under the laws of the State of Florida as filed on June 26, 2006 and assigned document number L06900064394, and confirms that these Amended and Restated Articles of Organization hereby amend and restate the provisions of the Company's original Articles of Organization in their entirety:

ARTICLE I. NAME

The name of the Company is **PEARL CHU KWONG M.D., LLC** (the "*Company*").

ARTICLE II. ADDRESS


