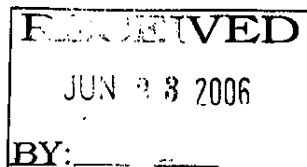

**ARTICLES OF ORGANIZATION
OF

The undersigned, for the purpose of forming a Professional limited liability company under the Florida Limited Liability Company Act, F.S. Chapter 608 and Chapter 621, does hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I -- NAME

The name of the limited liability company shall be **THOMAS C. WILLIAMS PE, PLC** ("Company").

ARTICLE II -- ADDRESS

The street address of the principal office of the company shall be **WILLIAMS ENGINEERING, PLC, 206 Live Oak, New Smyrna Beach, Florida 32168**, and the mailing address is the same.

ARTICLE III -- PURPOSE AND DURATION

The company is formed for the purpose of providing professional engineering services to the general public. The company shall commence its existence on the date the articles of organization were filed by the Florida Department of State. The company's existence shall be perpetual.

ARTICLE IV -- REGISTERED OFFICE AND AGENT

The name and street address of the registered agent of the company in the State of Florida is **THOMAS C. WILLIAMS**, at 206 Live Oak, New Smyrna Beach, Florida 32168.

ARTICLE V -- CAPITAL CONTRIBUTIONS

The members of the company shall contribute all of the capital of the company in cash or property.

ARTICLE VI -- ADDITIONAL CAPITAL CONTRIBUTIONS

The members shall make additional capital contributions to the company as the members determine necessary.

ARTICLE VII -- ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the company except with the written consent of the members of the company and on such terms and conditions as shall be determined by the members. A member may transfer its interest in the company as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the company or become a member unless the member of the company proposing to dispose of its interest approves of the proposed transfer by written consent.

The company shall be dissolved on the death, bankruptcy, or dissolution of the members or on the occurrence of any other event that terminates the continued membership of the members in the company.

ARTICLE IX -- MANAGEMENT

The company shall be managed by the members in accordance with regulations adopted by the members for the management of the business and affairs of the company. These regulations may contain any provisions for the regulation and management of the affairs of the company not inconsistent with law or these articles of organization. 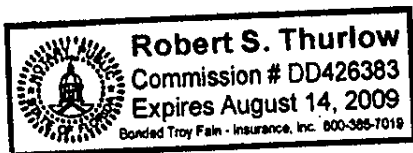
