WOLFE & KING RESIDENTIAL, L.L.C., a limited liability company organized and existing under the laws of the State of Florida (the "Company"), in order to amend its Articles of Organization, in accordance with the requirements of Chapter 608, Florida Statutes, hereby certifies as follows:

1. The Articles of Organization of the Company were filed by the Secretary of State of the State of Florida on June 26, 2006.

2. The Amendment to the existing Articles of Organization being effected hereby is that resulting from completely deleting Article I of the Articles of Organization as of the date hereof, and by substituting in its place the Article set forth below.

3. As amended below, Article I of the Articles of Organization has the sole effect of changing the Company's name from "WOLFE & KING RESIDENTIAL, L.L.C." to "WOLFE & KING, L.L.C." The Amendment to the existing Articles of Organization being effected hereby will make no change in the current capital structure of the Company.

4. This Amendment to the Articles of Organization was approved by a unanimous Written Consent of the Managers and Members of the Company, adopted on July 14, 2006. The number of votes cast for this Amendment by the Managers and Members was sufficient for approval of this Amendment.

5. The Amended Articles of Organization shall be effective immediately upon filing by the Department of State of the State of Florida, all required taxes and fees having been paid, and
