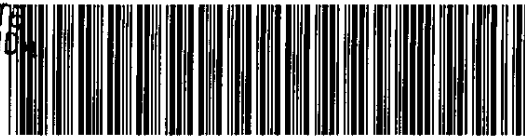



ARTICLE I – NAME

The name of the Limited Liability Company is: **DIANE M. STENDER
