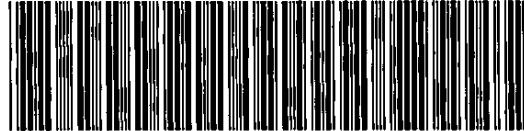

### Continuation of Business

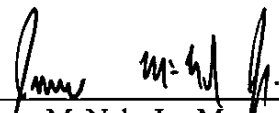

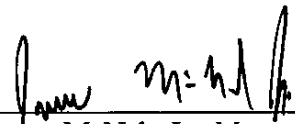

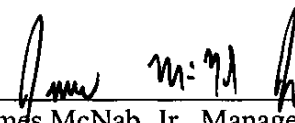
