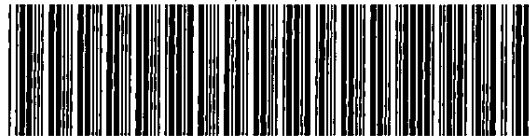



The name of the Limited Liability Company is Centurion Acquisitions, LLC.




