PERIOD OF DURATION**

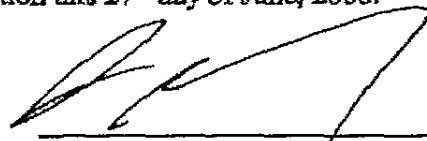
ARTICLE 6 OPERATING AGREEMENT

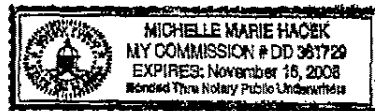
