ARTICLE 1 NAME

The name of this company is RETINA VITREOUS CONSULTANTS OF WEST FLORIDA, P.L.

ARTICLE 2 PERIOD OF DURATION

This company shall commence as of the date these Articles of Organization are filed with the Department of State of the State of Florida and shall exist perpenally thereafter, unless this company is dissolved pursuant to the terms of the operating agreement for this company or by operation of law.
