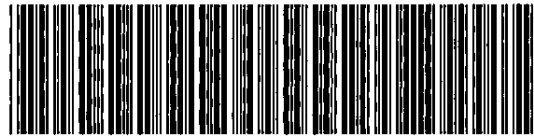

1. **Name.** The name of this limited liability company is **DCS AVILA INVESTMENT, LLC** (the "Company"), and it shall be formed as a limited liability company under Chapter 608 of the laws of the State of Florida.

2. **Duration.** The existence of the Company shall be effective upon filing and shall thereafter be perpetual.

3. **Purpose.** The Company is organized for the purpose of transacting all lawful activities and businesses that may be conducted by a limited liability company under the laws of Florida.

4. **Place of Principal Office.** The mailing address and the street address of the Company's principal office is 509 Guisando de Avila, Suite 200, Tampa, Florida 33613-5253.

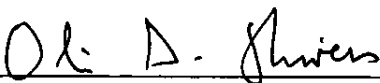

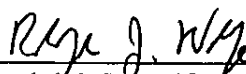
