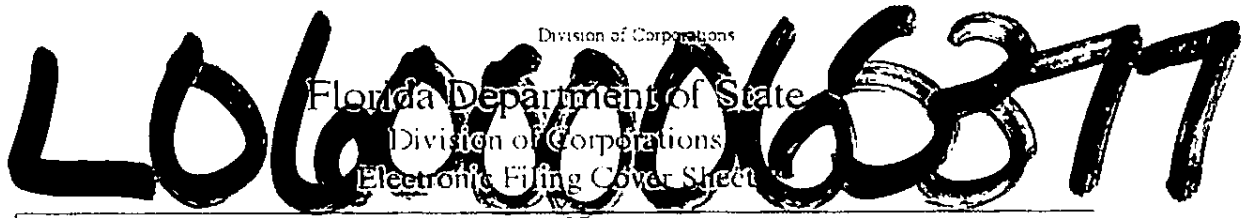

Pursuant to the provisions of Florida Statutes §605.0202(4), the above-named Florida limited liability company hereby adopts the following Amended and Restated Articles of Organization, which amend and restate the Articles of Organization originally filed on June 28, 2006.

The undersigned for the purpose of forming a limited liability company under the Florida Revised Limited Liability Company Act, Florida Statutes Chapter 605, hereby make, acknowledge, and file the following Amended and Restated Articles of Organization pursuant to Florida Statutes §605.0202(4).

ARTICLE I
NAME

The name of the limited liability company shall be HIGH Q AUTOMOTIVE CONSULTING, LLC (the "Company").

ARTICLE II
ADDRESS

The initial mailing address and street address of the principal office of the Company is 747 N. State Road 7, Plantation, Florida 33317.

ARTICLE III
DURATION

The Company shall commence its existence on the date the Articles of Organization are filed with the Florida Department of State. The Company's existence shall be perpetual unless the Company is dissolved earlier as provided in these articles of organization or in the operating agreement.

ARTICLE V
ADMISSION OF NEW MEMBERS

Except as set forth in the operating agreement, no additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and on the terms and conditions as shall be determined by all the members. A member may transfer his or her interest in the Company as set forth in the operating agreement of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all of the members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by written consent.

ARTICLE VI
MANAGEMENT

The Company shall be a Manager-Managed company as provided in Florida Statutes, §605.0407, and shall be managed by the Managers in accordance with Florida law and the operating agreement adopted by the Members for the management of the business and affairs of the Company. The operating agreement may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these articles of organization. Set forth below is/are the name(s) of the initial Managers of the Company, who has/have been duly designated to manage the Company as provided in Florida Statutes, §605.0407, and who will have the respective titles set forth below, with each Manager independently having the capacity to bind the Company and make decisions on behalf of the Company without the consent of the other Managers:

INDEMNIFICATION




ARTICLE VIII






