ARTICLE FIVE

INDEMNIFICATION

The rights accruing to any person under the foregoing provision shall not exclude any other right to which he/she/it may be lawfully entitled, nor shall anything therein contain or restrict the right of the Company to indemnify or relimburse such person in any proper case even though not specifically provided for herein.
