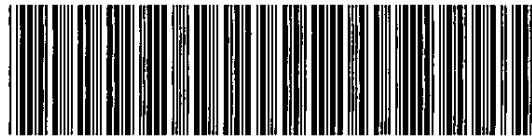



FIRST: The date of filing of the Articles of Organization was June 28, 2006.

SECOND: The following amendment to the Articles of Organization were adopted by the limited liability company:

A. Article Ten is hereby deleted, and the following is substituted in its place:

"ARTICLE TEN

Graham shall own an undivided sixty-five percent (65%) interest in this limited liability company and Roger Cleveland shall own an undivided thirty-five percent (35%) interest in this limited liability company. Therefore, Carey E. 
