The undersigned, for the purposes of amending and restating the Articles of Organization of Children's Equity, LLC, originally filed with the Department of State of Florida on June 28, 2006, under the Florida Limited Liability Company Act, F.S. Chapter 608, hereby makes, acknowledges and files the following Amended and Restated Articles of Organization.

**ARTICLE I**

**Name**

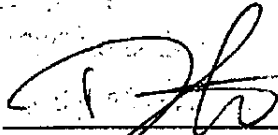

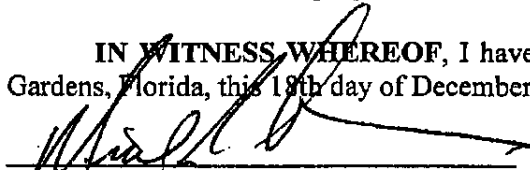
