# ARTICLES OF ORGANIZATION SECRETARY OF STATE FOR TALLAHASSEE, FLORIDA A PROFESSIONAL FLORIDA LIMITED LIABILITY COMPANY

The undersigned, desiring to form a professional limited liability company under Florida Statutes Chapter 621, the Professional Services Corporation and Limited Liability Company Act, hereby submits, and files with the Florida Department of State, these Articles of Organization.

- (e) Make contracts or guarantees, or incur liabilities; borrow money; issue its notes, bonds, or other obligations, which may be convertible into or include the option to purchase other securities of the Company; or make contracts of guaranty and suretyship which are necessary or convenient to the conduct, promotion, or attainment of the business of a corporation the majority of the outstanding stock of which is owned, directly or indirectly, by the contracting limited liability company; a corporation which owns, directly

- (k) Be a promoter, incorporator, shareholder, partner, member, associate, or manager of any corporation, partnership, joint venture, trust, or other entity.
- (l) Make payments or donations or do any other act not inconsistent with law that furthers the business of the Company.
