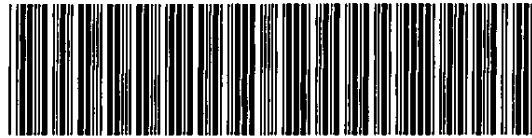

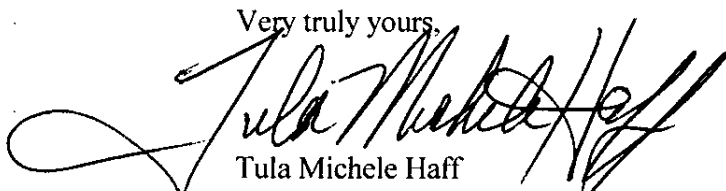

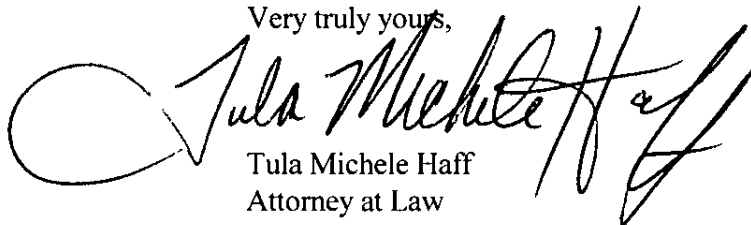

**VII.**           Amendments to Articles:

The managers cannot adopt amendments to the Company Articles of Organization or to the Operating Agreement without majority member consent.

**VIII.**          Dissolution of Company:

A proposal by management to dissolve the Company must be voted on by the Members.

- IX. Other provisions for the regulation of the internal affairs of the limited liability company:
- A. The Company shall indemnify an individual made a party to a proceeding because he is or was a member, manager, officer, employee or agent of the company against liability incurred in the proceeding if:
- (i) They conducted themselves in good faith; and
  - (ii) They reasonably believed that their conduct was in or at least not opposed to the Company's best interest; and
  - (iii) In the case of any criminal proceeding they had no reasonable cause to believe his conduct was unlawful.
- B. The Company shall pay for or reimburse the reasonable expenses incurred by a member, manager, officer, employee or agent of the Company who is a party to a proceeding in advance of final disposition of the proceeding if:
- (i) The individual furnishes the Company a written affirmation of his good faith belief that they have met the standard of conduct described herein;
  - (ii) The individual furnishes the Company a written undertaking executed personally or on his behalf to repay the advance if it is ultimately determined that they did not meet the standard of conduct; and
  - (iii) A determination is made that the facts then known to those making the determination would not preclude indemnification under the law.
- C. The indemnification and advance of expenses authorized herein shall not be exclusive to any other right to which any member, manager, officer, employee or agent may be entitled under any By-law, regulation, agreement, vote of members or disinterested managers or otherwise. The Articles of Organization shall not be interpreted to limit in any manner the indemnification or right to advancement for expenses of an individual who would otherwise be entitled thereto. These Articles of Organization shall be interpreted as mandating indemnification and advancement of expenses to the extent permitted by law.
- D. The principal place of business of the Company shall be in Florida or at such other place as the members from time to time may agree.

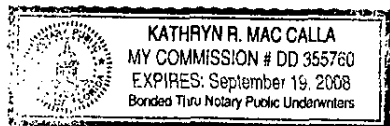
