

ARTICLES OF ORGANIZATION for

RADHA, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Chapter 608, Florida Statutes, hereby makes, acknowledges and files the following Articles of Organization.

ARTICLE I NAME

The name of the limited liability company shall be Radha, LLC ("Company").

ARTICLE II- ADDRESS

The mailing address and street address of the principal office of the Company shall be 1181 Airport Road, Jacksonville, Florida 32218.

ARTICLE III DURATION

The Company is to exist perpetually.

ARTICLE IV PURPOSES AND POWERS

The general purpose for which the Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

ARTICLE V MANAGEMENT

The Company shall be managed by one (1) or more managers and is, therefore, a member-managed company.

ARTICLE VI- INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office of the Company is 1181 Airport Road, Jacksonville, Florida 32218 and the name of the initial registered agent for service of process at that address is Pankaj C. Brahmbatt.

ARTICLE VII ADMISSION OF NEW MEMBERS

No additional members shall be admitted to the Company except with the unanimous written consent of all the members of the Company and upon such terms and conditions as shall be determined by all the members. Members may transfer their interests in the Company as set forth in the Operating Agreement of the Company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

ARTICLE VIII INDEMNIFICATION

The company shall indemnify its members, managers, officers, employees, and agents to the full extent permitted by law.
