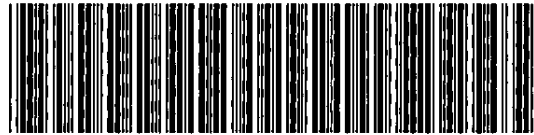

NAME**

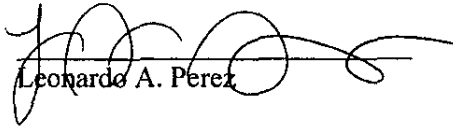
