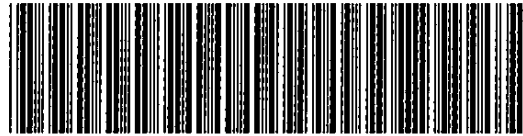

**ARTICLES OF ORGANIZATION
OF
STELLAR LAND, L.L.C.**

1. Name. The name of the limited liability Company (hereinafter referred to as "Company") is: STELLAR LAND, L.L.C.
