The remaining members of the company have the right to continue the business of the company in the event of the death, retirement, resignation, expulsion, bankruptcy or dissolution of any member.

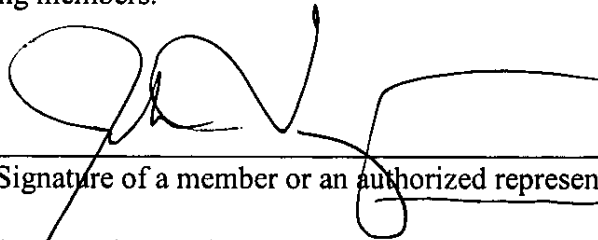
