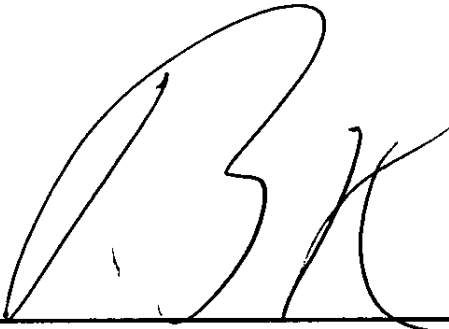

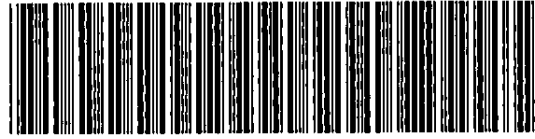

Pursuant to Section 608.411 of the Florida Limited Liability Company Act (the "Act"), Selah SeniorCare-Village View, LLC, a Florida limited liability company (the "Company"), hereby submits these Articles of Amendment to the Articles of Organization of the Company:

FIRST: The name of the Company is SELAH SENIORCARE-VILLAGE VIEW, LLC.

SECOND: The Articles of Organization of the Company, then-named Selah SeniorCare-Palmer Club, LLC, were filed with the Florida Department of State on July 6, 2006 and the Articles of Amendment changing the name of the Company to Selah SeniorCare-Village View were filed with the Florida Department of State on December 4, 2006.

THIRD: Article I of the Articles of Organization of the Company, as amended, is hereby deleted in its entirety and the following is substituted in lieu thereof:

"ARTICLE I

NAME

The name of this Limited Liability Company is: PVHA/SIMS-TUPELO, LLC."

FOURTH: The foregoing Amendment was duly adopted by the Members of the Company on March 26, 2007.
