ARTICLES OF ORGANIZATION OF

HUNTER REAL ESTATE, LLC

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act, Florida Statutes Chapter 608, hereby makes, acknowledges, and files the following Articles of Organization.

ARTICLE 1 - NAME

The name of the limited liability company shall be **HUNTER REAL ESTATE, LLC**, ("Company").

ARTICLE 2 - ADDRESS

The principal place of business of the Company in Florida shall be 500 West Cypress Creek Road, Suite 780, Fort Lauderdale, Florida 33309 and the mailing address shall be the same.

These Articles of Organization shall be effective immediately upon approval of the Secretary of State, State of Florida.




