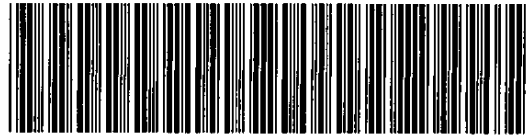

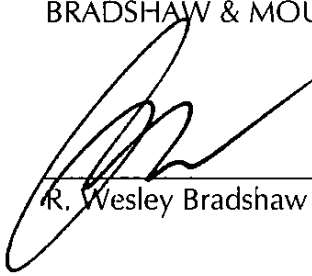

# ARTICLES OF ORGANIZATION

OF

## **FISH BAR, LLC**

The undersigned, under the provisions of Chapter 608 of the Florida Statutes (the "Act"), for the purpose of forming a limited liability company under the laws of the State of Florida, do set forth the following:

### **ARTICLE I – NAME**

The name of the limited liability company is **FISH BAR, LLC** (hereinafter referred to as the "Company").

### **ARTICLE II – DURATION**

Unless earlier terminated under the Act or the Operating Agreement, the period duration of the Company shall be perpetual.

### **ARTICLE III - PURPOSE**

The purpose for which the Company is organized is to engage in real estate acquisition and management and any and all other business and activities permitted by the Act and any other applicable laws of the State of Florida. The Company shall have all of the powers vested in a limited liability company organized and existing by virtue of such laws.

### **ARTICLE IV – ADDRESS OF BUSINESS**

The mailing address for the Company is 7410 Gospel Island Road, Inverness, Florida 34450, and the street address of the place of business for the Company is 7410 Gospel Island Road, Inverness, Florida 34450. These addresses may be changed from time to time as provided in the Operating Agreement.

### **ARTICLE V – REGISTERED AGENT**

The initial registered agent in Florida for the Company is R. Wesley Bradshaw, Esquire, and the initial registered office is located at 209 Courthouse Square, Inverness, Florida 34450.

### **ARTICLE VI – CAPITAL CONTRIBUTION**

Contributions to the capital of the Company shall be made by the members, in the manner prescribed by the written Operating Agreement made and entered into by the members and which may be amended from time to time in accordance with its terms.

## **ARTICLE VII – MEMBERS**

The Company shall have at least one member and may admit additional members on the prior unanimous written agreement of the then-existing members, or as otherwise provided in the Operating Agreement.

## **ARTICLE VIII – CONTINUITY OF BUSINESS**

On the death, retirement, resignation, expulsion, bankruptcy, or dissolution of a member, or on the occurrence of any other event that terminates the continued membership of a member in the Company, or upon any other event that, under the Act, would result in dissolution of the Company, the business of the Company may be continued and the Company will not be dissolved without the prior written consent of all the remaining members of the Company.

## **ARTICLE IX- MANAGEMENT**

This Company will be managed by one or more managers appointed by the members in accordance with the terms of the Operating Agreement. As such, the Company will be manager-managed. The members, at a meeting of the members held not less than annually, shall designate the managers, who may also be members. The initial managers, who shall serve until the first annual meeting of the members or until their successors are elected and qualify shall be as follows:

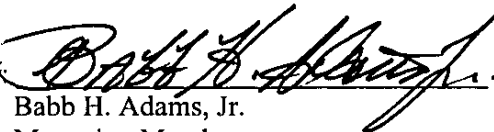
## **ARTICLE X – INDEMNIFICATION**

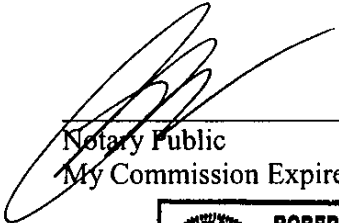

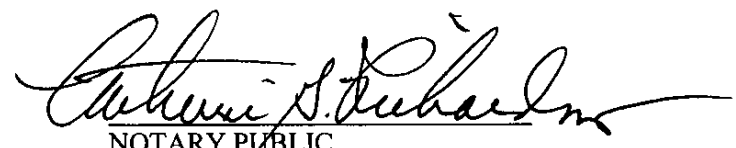

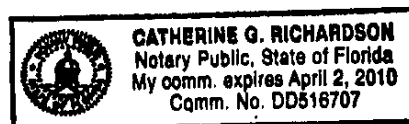
