ARTICLES OF ORGANIZATION  
OF  
DeSotos Enterprises, L.L.C.

The undersigned, for the purpose of forming a limited liability company under the Florida Limited Liability Company Act hereby make, acknowledge, and file the following Articles of Organization.

ARTICLE I-NAME

The name of the limited liability company shall be DeSotos Enterprises, L.L.C. ("Company"). The principal place of business of the Company in Florida shall be 4390 S.W. 14<sup>th</sup>. St., Coral Gables, Fl. 33134.

ARTICLE II-PURPOSES AND POWERS

The general purpose for which the Company is organized is to transact any lawful business for which a limited liability company may be organized under the laws of the State of Florida. The Company shall have all the powers granted to a limited liability company under the laws of the State of Florida.

ARTICLE III-REGISTERED OFFICE AND AGENT

ARTICLE IV-ADMISSION OF NEW MEMBERS

A member may transfer his or her interest in the Company as set forth in the regulations of the company, but the transferee shall have no right to participate in the management of the business and affairs of the Company or become a member unless all the other members of the Company other than the member proposing to dispose of his or her interest approve of the proposed transfer by unanimous written consent.

ARTICLE V-MANAGEMENT

The Company shall be managed by one manager in accordance with regulations adopted by the members for the management of the business and affairs of the Company. These regulations may contain any provisions for the regulation and management of the affairs of the Company not inconsistent with law or these Articles of Organization.

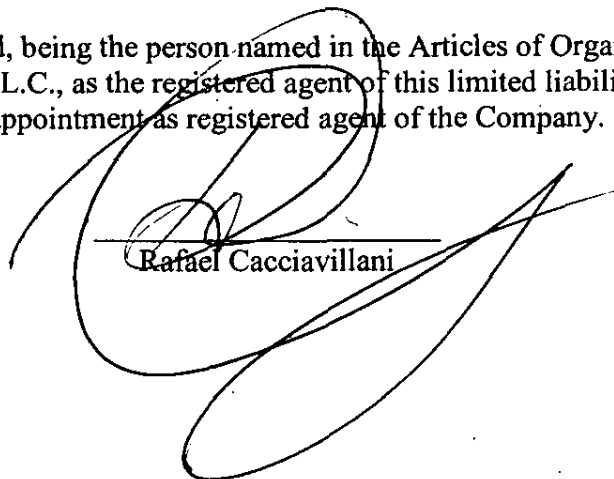
