ARTICLES OF ORGANIZATION FOR T.C. JOHNSON, L.L.C. a Florida Limited Liability Company

The undersigned, an authorized representative of a Member, desiring to formal limited liability company under and pursuant to Florida Statute 608, entitled the Florida Limited Liability Company Act, does hereby adopt the following Articles of Organization for such company.

ARTICLE I - NAME

The management and control of the Company shall be vested in its members unless and until a manager is elected by a majority of members.
